**ORDINANCE NO. 159**

**AN ORDINANCE ESTABLISHING REVISED RATES FOR WATER AND SANITARY  
SEWER SERVICE PROVIDED BY THE GLENBROOK SANITARY DISTRICT**

**WHEREAS**, the Glenbrook Sanitary District (the “District”) is a duly organized unit of local government and body politic created and operating under the Sanitary District Act of 1936, 70 ILCS 2805/0.1, *et seq.* (the “Act”); and

**WHEREAS**, Section 4 of the Act authorizes the Board of Trustees of the District (the “Board”) to exercise all the powers and manage and control all the affairs and property of the District; and

**WHEREAS**, the Board’s authority referenced above includes, without limitation, the power to pass all necessary ordinances, rules and regulations for the proper management and conduct of the business of the Board and the District; and

**WHEREAS**, the District imposes certain rates and charges (collectively, the “Rates”) for water and sewer services (collectively, the “Services”) that it provides to customers whose property lies within the territorial jurisdiction of the District, which Rates are subject to amendment from time to time; and

**WHEREAS**, in order to ensure that sufficient revenues are available to satisfy operations and maintenance obligations, depreciation and other costs related to the District’s utility systems and provision of the Services, the Board has determined that it is in the best interests of the District, and in furtherance of the public health, safety and welfare, to amend the District’s Rates in the manner set forth herein;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Glenbrook Sanitary District, Cook County, Illinois, as follows:

**SECTION 1.** The statements contained in the preamble to this Ordinance are true and correct and are incorporated into this Ordinance as if set forth in full.

**SECTION 2.** The following water Rates for residential Customers are hereby adopted, effective **November 1, 2022**: (a) **\$3.562/** per 1000 gallons of water consumed per monthly bill for admin. expenses; (b) **\$2.019/** per 1000 gallons of water consumed per monthly bill for capital cost; (c) **\$5.007/** per 1000 gallons of water consumed per monthly bill for water purchase.

**SECTION 3.** The following water Rates for commercial Customers are hereby adopted, effective **November 1, 2022**: (a) **\$3.562/** per 1000 gallons of water consumed per monthly bill for admin. expenses; (b) **\$2.019/** per 1000 gallons of water consumed per monthly bill for capital cost; (c) **\$5.007/** per 1000 gallons of water consumed per monthly bill for water purchase.

**SECTION 4.** The following sewer Rates for residential Customers are hereby adopted, effective **November 1, 2022**, and shall be added to residential Customers' water bills: (a) **\$1.02/** per 1000 gallons of water consumed per monthly bill for admin. expenses; (b) **\$1.46/** per 1000 gallons of water consumed per monthly bill for capital cost.

**SECTION 5.** The following sewer Rates for commercial Customers are hereby adopted, effective **November 1, 2022**, and shall be added to commercial Customers' water bills: (a) **\$1.02/** per 1000 gallons of water consumed per monthly bill for admin. expenses; (b) **\$1.46/** per 1000 gallons of water consumed per monthly bill for capital cost.

**SECTION 6.** A surcharge is hereby imposed at the rate of \$3.00 for the handling and processing of monthly billing by the District. This surcharge shall be in addition to any and all other surcharges or taxes imposed. In the event the Customer elects to utilize the District's electronic billing process, the surcharge would be removed from said Customer's monthly bill.

**SECTION 7.** This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law. If any portion of this Ordinance is determined to be invalid by a court of competent jurisdiction, that portion shall be stricken, and the remainder of this Ordinance shall continue in full force and effect.

**SECTION 8.** All ordinances, resolutions, rules, regulations, orders and policies, or parts thereof, in conflict with this Ordinance are hereby superseded to the extent of such conflict.
